#### **Treasurer's Report**

No report from Chris, Rick reported currently, as of today we have \$22,311.05 in the checking account. \$250.00 of which ill be paid out to Kelly Cawthorne on a monthly invoice April 22, 2019. Between last meeting and this meeting, I pulled out the Deward Beeler Scholarship money that was in the checking account, so we don't spend it and put into a brand-new savings account rather than a CD, this way the money is accessible. There was \$1797.00 that was deposited. The over all total in accounts is \$24,108.05. ## Fire Fighter Training Council (Blomstrom)

Blomstrom reported that the Council had their meeting prior to ours. They took care of all the special meetings that the council went to. In SMOKE the Arson Detection for the First Responders class was locked down and replaced with Fire Investigation for First Responders that was supposed to happen a year ago. Fire Marshall needs to talk with the State Police about ICS 300-400 that there will be duel enrollment between SMOKE and MI Training for anybody that is teaching the class. MIOSH is updating for Live Fire Training as far as Part 74. Go to MIOSHA about that. Motion to remove the Instructor 2 Moratorium that was voted down 6 to 3. Motion to have the council packet out online as close to the meeting as possible for more transparence to the meeting and that passed. There is no set time period before the meeting could be the day of the meeting. Discussion about general rules and the update. Basically, the document has been gone through and is in a second review, as soon as that is done to see if they missed anything it will go to the council for a final vote. IFSTA and J&B implementation dates the idea is to have the new curriculum start October 1st. New NFA class has been adopted, Who Protects Firefighters from Firefighters, proposed by Dan

Hammerberg and was passed contingent on the fact the NFA will allow it to be a hand off class and a few of the Q Courses were passed. Discussion held.

South VP Wlosinski reported lot of time will be spent on the practical evaluation sheets for ff1 & ff2. Any changes talk to Ray. Discussion Held.
