## Instructor Bio's

### **Shaun Abbey – Leadership, Promotions**

Shaun Abbey has been in the fire service since 1990, starting out attending Kellogg Community College for Fire Science and working as a Paid-on-Call Firefighter in Springfield (MI). He has worked for the Kentwood Fire Department for the past 29 years serving as a Firefighter/EMT, Lieutenant, Captain and is currently a Battalion Chief.
